Recommendation: <u>We recommend awarding Base Bid No. 1 and Alternate No. 1.3 to the Low Bidder, Darr Construction,</u> Inc., in the bid amount of \$171,250. This would include replacing the parking lot poles and lights with LED lights and relamping the interior terminal building lights to be LED lights, as well as surge protection for the parking lot and terminal building lights. The existing parking lot lights often fail and need replaced</u>. Moving forward with this project would both improve safety and visibility at night, as well as provide a cost saving by switching to LED lighting.
